More teachers from the farthest reaches which is exciting. Texoma looks promising and we should start to plan for the spring chapter auditions
 - i. Sean Taylor asked if there was any concern with using YouTube and copyrights? Melinda answered that those entering should Label their clips "unlisted" and also, not "listed as content for children". If it's public then it will go through the copyright filters.
